An Ordinance levying taxes for the Nunda Township Road District, McHenry County, State of Illinois.

The Highway Commissioner of the Nunda Township Road District on the 14th day of December, 2010, does hereby determine and declare that the amount necessary to be raised by taxation and levied for Road purposes for said Road District for the year 2010 is as follows:

We further recommend that there be levied for the NUNDA TOWNSHIP ROAD DISTRICT for the uses and purposes aforesaid for the **GENERAL ROAD FUND** the sum of **ONE MILLION, ONE HUNDRED SEVENTY-EIGHT THOUSAND, ONE HUNDRED NINETY-SIX DOLLARS AND 00/100 (\$1,175,196.00)**


We further recommend that there be levied for the NUNDA TOWNSHIP ROAD DISTRICT for the uses and purposes aforesaid for the **PERMANENT HARD ROAD FUND** the sum of **ONE MILLION, NINE HUNDRED EIGHTY-ONE THOUSAND, SIX HUNDRED TWENTY-FOUR DOLLARS AND 00/100 (\$1,981,624.00)**

We further recommend that there be levied for the NUNDA TOWNSHIP ROAD DISTRICT for the uses and purposes aforesaid for the **INSURANCE FUND** the sum of **SIXTY THOUSAND, SIX HUNDRED NINETY-ONE DOLLARS AND 00/100 (\$60,691.00)**


We further recommend that there be levied for the NUNDA TOWNSHIP ROAD DISTRICT for the uses and purposes aforesaid for the **SOCIAL SECURITY FUND** the sum of **SIXTY-EIGHT THOUSAND, FOUR HUNDRED THIRTY-ONE DOLLARS AND 00/100 (\$68,431.00)**

We further recommend that there be levied for the NUNDA TOWNSHIP ROAD DISTRICT for the uses and purposes aforesaid for the **IMRF FUND** the sum of **EIGHTEEN THOUSAND, SIX HUNDRED SIXTY-EIGHT DOLLARS AND 00/100 (\$18,668.00)**
